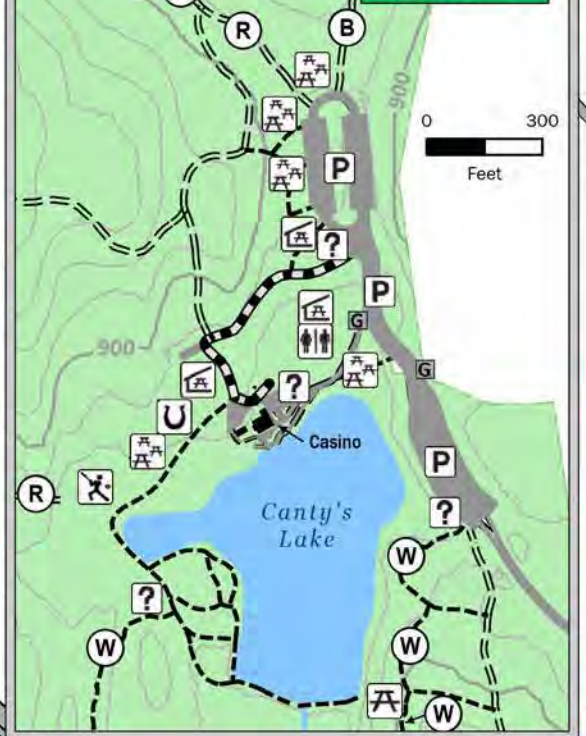
Dogs must remain on a 6' leash as per Article III, Section 3 of the Morris County Park Commission Rules and Regulations.

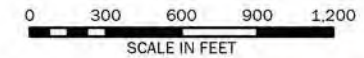
