**OTHER INFORMATION:**

- Lights - Lights will be scheduled to turn on and off with MUSCO’s automated system.
  - The Turf Fields, Challenger Field, Volleyball Courts, and In-Line Rinks have Lights. Softball does not.
- Use of Radio/Music/DJ/Band/P.A. System is not permitted
- Safety Precautions - First Aid Kits and AED’s are NOT provided.

**PAYMENT:**

- **10% Deposit (non refundable) is due 30 days** after receiving your invoice to secure your reservation.
- **The remaining balance is due 30 days prior to the start of your reservation.**
- If the reservation is made within 30 days of the reservation, full payment is due upon receipt of the invoice.

**CANCELLATION POLICY:**

All requests to cancel must be made in writing to the MCPC Recreation Office.

- **Less than 60 days prior** to the reservation date on the invoice requires payment of 30% the reservation fee.
- **Less than 30 days** from the reservation date on the invoice, No Refunds or Reduction Provided.
- **There are no refunds or rain dates for inclement weather.**

Morris County Park Commission Indemnification

Renter Indemnity:

The Renter shall indemnify, defend and hold harmless the Morris County Park Commission, the County of Morris, their employees, agents, Freeholders, professionals and volunteers (collectively “Morris County”) from and against any and all claims, losses, penalties, damages, settlement, costs, charges, professional fees (including attorney’s fees and related costs) and/or other expenses or liabilities of any nature whatsoever including, without limitation, the investigation and defense of any claims, arising out of the rental including, without limitation, claims for damage, or loss that (a) is attributable to bodily injury, sickness, disease or death, or to injury or to destruction of tangible property including the loss of use resulting therefrom, (b) is caused in whole or in part by any act or act of omission of the Renter, or their, exhibitors, vendors or anyone directly or indirectly employed or affiliated in a manner with the Renter. This agreement also applies to all volunteers of the Renter.
