Turf Access Card Registration

Complete the registration form and return it to the Recreation Department. A representative will contact you to confirm receipt of the application and send you your turf access card.

Access Card Information:

The Turf Access Card allows the approved card holder to use the 4 Artificial Turf Fields and Challenger Field (Mondo Turf), located at Central Park of Morris County, whenever the fields have not been rented/reserved.

• **Requirements -**

- Applicant must be a Morris County Resident.
- Turf Access Cards are for Individual Residents, not for organizations or businesses.
- Turf Access Card holders must be 10 years old or older.
 - Anyone under 10 years old may use the fields under the supervision of a Turf Access Card Holder over the age of 18.

• **Fees -** \$25 per card, for access (April- November of the current year, weather permitting).

- The Morris County Park Commission does not issue Refunds.
- Turf Access Card Holders must provide a photo of themselves to print on the card.
- Turf Access Card Holders may call the Recreation Department asking for Field Availability to find openings in the schedule when the fields have not been reserved.

• **Rules -**

- TAC's (Turf Access Cardholder) must follow all of the turf rules and regulations. Visit <https://www.morrisparks.net/turfrules> for a list of rules.
- TAC's are not allowed to use the fields when there is a reservation scheduled.
- The Turf Access Card only applies to the cardholder. It is name specific and cannot be used for multiple people.
- Carry the Turf Access Card and a picture ID with you when using the fields. The Turf Ranger may ask you for both to verify that you are an approved TAC.
- Pickup games are allowed amongst TAC's. Any organized play (possibly facilitated by an organization or business) requires a field rental.
- TAC's cannot hold private training sessions during open field time.
- TAC's are responsible for themselves and the fields. If you see anyone misusing the fields or find any damage, report it immediately to Park Police or the Recreation Department.
- Turf Access Cards may be revoked/canceled at any time.
- A violation of any of the Rules or Regulations may make you ineligible to obtain a card in the future.

Additional Information:

- **Safety Precautions -** Please be aware, First Aid Kits and AED's are not provided at this location.
- **Use of Radio/DJ/Band/P.A. System is not permitted**
- **Recreation Department -** Please call for field availability or to report any concerns/problems you may have noticed on the fields.

Morris County Park Commission Indemnification

Renter Indemnity:

The Renter shall indemnify, defend and hold harmless the Morris County Park Commission, the County of Morris, their employees, agents, Commissioners, professionals and volunteers (collectively "Morris County") from and against any and all claims, losses, penalties, damages, settlement, costs, charges, professional fees (including attorney's fees and related costs) and/or other expenses or liabilities of any nature whatsoever including, without limitation, the investigation and defense of any claims, arising out of the rental including, without limitation, claims for damage, or loss that (a) is attributable to bodily injury, sickness, disease or death, or to injury or to destruction of tangible property including the loss of use resulting therefrom, (b) is caused in whole or in part by any act or act of omission of the Renter, or their, exhibitors, vendors or anyone directly or indirectly employed or affiliated in a manner with the Renter. This agreement also applies to all volunteers of the Renter.

By signing below, you are agreeing to the terms of the Morris County Park Commission Indemnification and the terms of the Turf Access Card Registration form. You are also agreeing to follow the Morris County Park Commission Rules and Regulations along with the Artificial Turf Field Rules. Any damage or extra cleaning that may be required after your field use may also result in having your Turf Access Card revoked and/or additional fees.
